

# Planning Planning Decisions report 11th July 2023

#### **Recent Planning Decisions**

H/23/95115 – 21 Church Road – Demolition of existing conservatory and replace with single storey rear extension.

Planning Committee Decision: Raise No Objection

Borough Council Decision: Permit.

T/23/95209 – Bishopstoke Manor – 1 no. Ginkgo (T1) -Proximity prune to clear property by up to 2m: max cut size 60mm diameter. To reduce likelihood of direct damage to building and to allow maintenance. 1 no. Robinia (T2)- Fell leader back to attachment point to remove risk of failure - within falling distance of neighbouring property. Trim small diameter (max 50mm diameter) epicormic growth up to 2m above ground level to reduce risk of harm while using garden and carrying out maintenance.

Borough Council Decision: Consent.
