### Assets – 28<sup>th</sup> May 2024 Item 5 – Updates

#### **Asset Transfers**

No further news since the last meeting, meaning that the state of asset transfers is as follows:

**Sewall Drive** (Allotments, Cemetery Extension, Open Space) – Eastleigh Borough Council are satisfied that the land passes the various tests necessary to be accepted by them and that sufficient time has passed that the usual twelve month maintenance period is not necessary. The Borough Council have committed to installing standpipes at the allotments and two further pipes at the Cemetery extension. There is a potential decision for Bishopstoke Parish Council regarding the surface of paths at the allotments which were intended to be compacted hoggin but instead are a cheaper compacted gravel which may well spread stones and cause difficulties for wheelbarrows or wheelchairs.

The remaining item for the Borough Council to agree with the developer is the provision of a shed on each plot. The Borough is suggesting that rather than providing a shed on each plot, the developer provide a pot of money which the Borough (and then Parish) could use to provide sheds to those that want them.

It is still the intention to use part of the allotment building there as a temporary office when the site is handed over. The Borough have agreed to help with converting one of the rooms in that building to office use. There may be a need for insulation and additional power sockets. Wifi / broadband will be required and there are some essential works to be done to make the building properly accessible to all. This transfer is described as "very soon" by Borough Council officers.

**Bow Lake Gardens** (Allotments, Community Orchard, Open Space, Woodland, Play Area) – The Borough Council are still working through some areas that the developer needs to finish with regard to drainage, despite the fact that the Borough accepted the land from the developer several years ago now. The Parish Council position remains that there is substantial work to be done to the allotments site before it can be used for that purpose and it is not clear where the money for that could come from.

**Rose Close** (Open Space) – The Parish Council has previously expressed concern over the exact "red line" map of the area to be handed over, in particular regarding whether the areas of planting are to be transferred. Additionally, there are potential issues with trees that are part of the package and the bench is located in a very bad spot in terms of drainage and waterlogging.

**Blackberry Drive** – this remains managed under licence by the Parish Council, from the Borough Council, and is unlikely to change any time soon. The Parish has exactly the same responsibilities and rights that it has had for more than 10 years and can work on the play area, install bins, benches and so on as it chooses and hold events just as if it owned the land.

### Memorial Hall

Full planning permission from the Borough Council has now been given, subject to either the Land Registry finalising their work or the Parish Council indemnifying the Borough Council against the possibility of someone stepping forward to claim the land as theirs during the demolition work.

The Parish Council solicitor has finally provided an update. I am told that although they intended to file a request with the Land Registry for an expedited decision in March after the Parish had supplied further comment from the Borough Council, it appears that that was never filed. It has now been done and we should hear back within days as to whether they will expedite things. I will be receiving a further update on Tuesday 28<sup>th</sup> May.

Separately, the solicitor has said that they cannot really comment on the wisdom of indemnifying the Borough Council and advised that the Parish talk to its insurers, which I will action as soon as possible.

#### War Memorial

As part of ascertaining the status of various projects following the resignation of the Assets Officer I was able to determine that the Parish had received a request for further information regarding the moving of the War Memorial from the Winchester Diocese which had never been actioned. I provided the information requested on May 20<sup>th</sup> which I was told was the deadline for the project to be included for discussion at the next meeting of the Diocese on June 12<sup>th</sup>. All being well the Parish will hopefully be granted permission to install the Memorial on Old St Mary's shortly after that and we should be able to proceed quickly to complete things over the summer. This will give plenty of time for the Memorial to be re-dedicated and then used for Armistice Day 2024.

We are still awaiting the results of the mitigation plan for water voles, bats and stag beetles required by the Borough Council as part of being granted planning permission but this should be forthcoming soon, hopefully by the end of May.



### Assets – 28<sup>th</sup> May 2024 Item 6 – Play Area Strategy Timetable

The previous Council directed officers to produce an analysis of current play areas, what equipment was available at each, what age ranges each area is targeted at, the likely lifespan left of equipment at each area, estimated costs for replacement and suggestions for what age range *should* be the target for each area, based on current usage and local population. The first step in completing this project is to agree a timetable for these actions to take place.

Councillors should note that with current staffing as it is there is a real possibility of any agreed timetable slipping until such time as new staff are brought on board and trained.

### Assets – 28<sup>th</sup> May 2024 Item 7 – Sayers Road play area

The Council has received an increasing number of comments and complaints about the activities of youths using Sayers Road play area. These complaints are focussed on ball games. Football and other ball games are being played on most days and nearby residents report that balls are regularly being kicked from the play area into their gardens. This is despite the presence of the hedge & tree line, and the wall / fence between the play area and the dwellings.

Residents are reporting being regularly disturbed by requests to retrieve balls – sometimes as many as five or six times in an afternoon. There have also been several near misses with balls coming close to hitting residents' grandchildren. When residents are not in, or simply say "no", the youths go back to the play area and climb over the walls into the back gardens to fetch the balls themselves. In the process they are potentially damaging the wall and any planting they land on in the gardens, and trespassing, as well as potentially hurting themselves.

Complaints to parents receive no support but instead parents become angry at the idea that their children are doing anything wrong by entering gardens without permission by climbing over a 6 ft wall. Residents are reportedly reluctant to report matters to the police as they fear being found out and targeted.

One of the residents has a wall that starts very low and then slopes up to full height. Youths can often be seem climbing up the wall to jump off, or just using that wall and the resident's driveway as a convenient way to get in and out of the play area instead of using the actual gate.

Residents have asked whether the Council can do anything to help and have suggested higher walls, cutting trees and hedges lower, more regularly, so that the youths cannot use them to help get over the wall, and putting netting either between the wall and the planting, or the planting and the play area.

There is no specific recommendation for this item but it would certainly be possible to keep the hedge and tree line lower, although that may result in more balls going over. It would also be possible to obtain quotes for netting to be installed but that may result in the nets being vandalised or torn. In the end this may well be another thing that moves on of its own accord.
